February 10, 2021 at 8:15 pm

Meeting was called to order by Dean Nelson and opened with prayer.

Call for Additional Agenda Items:

- Replacement of light bulbs in the fellowship hall was added to the trustees' report.

Approved the Council Minutes from January 13, 2021.

Deacons' Report presented by Rod Scheel:

- Organization of the Deacon board: Rod Scheel as chair, Paul Christenson as secretary, Wayne Swenson as Children's Ministry liaison.
- Reviewed the Deacon/Shepherd list. The goal is to make contact every two months.
- Discussed 2021 Activities: Children's Ministry board has requested a VBS team for this summer from FLBC. Confirmation Service planned for early June. Planning a sermon series on the book of Ezekiel after Easter.

General Fund Balance: \$14,457.21

Noteworthy items:

Old Business:

Excess Facility Improvement Funds:

Moved and seconded to allocate the excess funds in the facilities improvement budget as recommended by the Deacons.

New Business:

Church Facility Use:

The Council discussed use of the church facilities for functions such as graduations or confirmations this spring. It was reaffirmed that the church is subject to the guidelines set by the Minnesota Department of Health. Currently, it is not feasible to host a large group, but this is subject to change dependent on MDH guidelines.
